The decision to become parents was the scariest decision Michael and I ever made in our lives. The fear of the unknown had never scared us before like it did with the idea of having another human-being 100% dependent upon us. We were the definition of spontaneous, deciding to go to the beach on a Thursday morning and being there Thursday night kind of crazy spontaneity. We loved our life pre baby and were scared to death how it would change.

Needless to say 2 years and three months after the birth of our precious baby girl Ashton, we are still at times scared to death, but we are beginning to get our bearings as parents. We may not be as spontaneous as we once were but we have never been happier. We owe this happiness to the wonderful Dr's and staff at the Kiran Infertility Centre, Hyderabad, India.

From the first visit to the clinic in 2009, to the birth of our baby in 2010, Kiran Infertility Centre made our surrogacy experience better than we could have ever imagined. Last year KIC introduced their first US based case manager, Alexis Thomas. She joined the team in 2011 and started working with donors from North America. Then in October 2011 she started working with US based Intended Parents. Alexis was introduced to KIC in 2010 as a donor. She had been a donor multiple times in the US and did her last donation at KIC for a friend. The relationship between KIC and Alexis developed from there and she became the US Case Manager based in Seattle, WA. Alexis helps to coordinate medications, Visa assistance, and general logistical questions about our surrogacy program. Dr. Samit felt that she would be a great asset to the team to help ease people's apprehensions about traveling to India for surrogacy. She has also gotten the clinic involved in various conventions around the country as well as assist with planning KIC's first international surrogacy seminar.

A CHALLENGING CASE

Nick and Mona (names changed for confidentiality) lost a baby boy following an intrauterine blood transfusion during their fifth month of pregnancy due to severe red blood cell all immunization (RH sensitization, as well as several other blood cell incompatibilities) in Chicago.

Mona has a unique 'blood grouping' that only allows her to safely carry a certain type of blood in her body. It happens that this 'blood grouping' is very rare. This makes pregnancy very difficult because her immune system perceives the baby's blood as something foreign and starts to attack it. Unfortunately, there is very little chance that Mona would be able to safely carry a child that her and Nick could create with each other. The baby would definitely grow inside her very sick, with a high risk for death, or other challenges such as cerebral palsy. After the acceptance that a relatively normal pregnancy was not in the cards in this life, they began to explore other options.

After a year of contemplation, research, discussion and tears they decided to embark to India and try surrogacy at the Kiran infertility Centre. They Approached KIC in December 2010 and underwent the IVF process with an embryo transfer into a surrogate mother and 9 months later were Blessed with a baby boy who will be turning 1 very soon.

NEW TECHNOLOGIES AVAILABLE AT KIC

Sperm Chromatin structure Assay (SCSA)

The Method used is : Flow Cytometry

This measures the Sperm Chromatin Decondensation (% SCD, Sperm with Immature Chromatin and Abnormal Proteins).

Debris and dead cells are not included in the analysis.

BASED ON % SCD LEVELS SPERM DECONDENSATION IS CLASSIFIED AS BELOW.

- a. Low Level $\leq 15\%$ SCD = Excellent to Good sperm DNA integrity. Normal sperm morphology and low level or no chromatin decondensation.
- b. Moderate Level $> 15\%$ to $< 25\%$ SCD = Good to Fair sperm DNA integrity. Poor sperm morphology and a high level of chromatin decondensation.
- c. High Level $\geq 25\%$ SCD = Fair to very poor sperm DNA integrity. Poor sperm morphology and a high level of chromatin decondensation.

Possibilities: Individuals on the higher end of the moderate SCD levels may have chances of negative results even after likely fertilization owing to chromatin damage beyond repairable capacity of the egg. Scientific evidence suggests when levels of sperm decondensation reach a critical threshold value of $>28\%$ the chances of pregnancy gets severely compromised.

JUNE IS PRIDE MONTH

In the US June is known as gay pride month. This demographic is a large portion of KIC's clients from all over the world. Every major city will celebrate gay pride month and KIC is joining the festivities. San Francisco's pride festivals is the biggest in the country. KIC will be an exhibitor at this event. We will be handing out a free informational brochure for pride attendees regarding our surrogacy and IVF services. KIC plans to inform pride attendees of their program and how people can work directly with our clinic in India.

UK CONSULATE OPENS IN HYDERABAD, INDIA

Until now, intended parents from United Kingdom had to travel to Delhi to visit the High Commission to process for citizenship and travel document for their new born baby/ babies. United Kingdom has announced about opening of its consulate in Hyderabad on Thursday 31st May 2012 making it the only country to have a consulate in all southern states except Kerala. For now, the consulate – to be headed by a deputy high commissioner - is expected to work out of a city hotel before it moves to a permanent address.

The UK consulate would bring the city closer to realizing its London dream which has to otherwise route its visa applications through the consulate office in Chennai. The consulate is set to place Hyderabad firmly on the global travel map, which the city has been figuring in over the last few years particularly after the international airport at Shamshabad came up. The city already has direct connectivity to UK with a daily British Airways flights to London. The flight reports more than 80% occupancy on most days, say official sources. Frequent flyers in the city hope that the consulate's presence in Hyderabad would connect city airport to more destinations in UK. Consulate offices often act as confidence boosters among travelers from their home nations, who feel comfortable visiting a city that has their consulate office. The consulate presence would also better people to people contact and an increased opportunity for state residents to avail of the various fellowships and scholarships of the UK government.

According to Dr. Samit Sekhar, Chief Embryologist and IVF & Surrogacy Program Director, Kiran Infertility Centre, "this will be an added advantage to all the parents who will be travelling to our facility for pursuing various treatments for infertility. Hopefully they will no longer need to go to Delhi to procure passports and travel documents for their new-born. They will be able to get them processed here in Hyderabad and this will also help in reducing the time of stay for parents post birth by approximately 3 to 4 days.
